Dirtbag Brands policy: We sell only to legitimate **Powersports Businesses** with a physical location (licensed places of business, open to the public during normal business hours - serving the public in areas of Powersports Sales, Service, and/or Parts and Accessories). We will only process applications for legitimate storefronts that are in the Powersports Industry. We do not engage in retail sales and reserve the right to refuse any account.

Dealer Application requirements:

- Must have a legitimate storefront dedicated to Powersports Business
- Include valid/current Powersports References
- Have a dedicated business phone/fax line
- A minimum order may be required
- Have a Federal Tax ID Number *photocopy proof required***
- State Re-Sale License *photocopy required***
- Business License *photocopy required***
- Send current pictures of building with Store Sign *Required***

Freight: Dirtbag Brands will pay shipping on all normal qualified orders to your dealership within the continental 48 states, over \$100.00. Freight must be pre-paid or freight collect on shipments to Alaska, Hawaii, Puerto Rico and other countries. We accept Visa, Mastercard, American Express and Discover. Dirtbag Brands will make every effort to ship the same day if orders are placed before 2:00 p.m. Mountain Time. Due to these conditions, orders cannot be changed or added to once it has been billed, a separate order would have to be placed. If the separate order is under the freight minimum, freight will be charged.

Merchandise Returns: Return Authorization (RA) required. To request an authorization number or for pre-approval on returns, please email with subject of, Returns, in the subject line, to info@dirtbagbrands.com. Returns for any reason other than “defective” will be subject to a restocking fee. All returns are subject to inspection for determination of credit. Items being returned must be in original shipping materials with the RA number on the outside of the package. Products returned without an RA will be held or refused and returned to the dealer. All RAs issued will have ONLY 30 days from the issue date to be returned before the RA is voided. After 30 days, it will be the dealer’s responsibility to return items to be considered for credit whether the items are defective or not. All sales are final on discontinued and closeout items.

Restocking Fee: Dirtbag Brands will charge customers a \$25.00 restocking for every package which a customer calls and cancels that has already been pulled, scanned, and placed on a truck for delivery.

Damaged, Short and Over Shipments: Dirtbag Brands must be notified within 10 days of invoice and noted on paperwork if merchandise is damaged or short to insure proper credit.

Disclosure of Restrictions: Retailer is authorized to sell only in their store front and/or their own website, unless approved in writing by the Company (for example, but not limited to, no eBay, Walmart or Amazon sales without written approval).

Completion and submission of this application acknowledges you agree to maintain all products to be sold within the walls of your fixed establishment. You may list products on the company website at, MSRP ONLY, with the name that is on the submitted dealer application. ABSOLUTELY NO ONLINE LISTINGS OR SALES OF DIRTBAG BRANDS PRODUCTS ON ANY THIRD PARTY SITES, such as Amazon, Ebay, Walmart, or any other third party entity will be tolerated. **Violation will result in no further order fulfillment or future fulfillment from Dirtbag Brands or any of its’ subsidiaries.**
